WHO CAN APPLY AND WAYS TO PAY FOR YOUR CPO SHARES

Anyone can apply for a CPO share, either for themselves or on behalf of someone else.

There is no limit to how many shares you can buy, either for yourself or as gifts. However, each individually named shareholder is limited to a maximum of 100 votes on any CPO company issue.

All shares issued by CPO are issued pursuant to the Articles of Association of CPO, copies of which are available from CPO at the address on page two of this form.

All applications must be accompanied by a photo ID and proof of current home address, such as a current utility bill.

You are not required to pay for your share(s) by making a single payment, although we do prefer that method. If you prefer to pay by instalments, you can choose from either of the **Standing Order** options described below.

SECTION C PAY WHEN YOU CAN SCHEME (Rolling Contributions) contd

<< share. This Scheme will continue until you decide to cancel your Standing Order. Each year you will receive a certificate showing the share numbers that have been allocated to you. Should you cease your contributions with a balance of under £100.00, this balance will be returned to you.

SECTION D FIXED STAGE PAYMENTS (Defined Contributions)

Having selected the type of share you wish to purchase, you can then select an amount to pay per month, from £25.00 upwards. This monthly amount cannot be altered. When your total payments reach the required amount, you will be sent the share you ordered. You will then be responsible for cancelling your Standing Order. If you forget to do this, any excess contributions would be returned to you. In the event that you do fail to make your regular payments, you would be given two months in which to resume your payments, after which you would lose the money already paid. If the amount paid is £100.00 or over, you would be registered with a share.
